## Valent BioSciences Unilateral Pricing Policy

Effective August 1, 2025, Valent BioSciences LLC (“Valent BioSciences”) published this Unilateral Pricing Policy for Retailers (“Retailer Pricing Policy”). This Retailer Pricing Policy applies to each Retailer and Dealer (each, a “Reseller”) and covers each product for which a “Minimum Suggested Grower Price” is included in the Suggested Retail Price provided by Valent BioSciences to such Reseller from time to time coinciding with official price changes or product introductions (each, a “Product”).

### PURPOSE

The intent of the Retailer Pricing Policy is to (i) protect the resale margins of Resellers to encourage them to continue to provide the high level of services and infrastructure which our end-users expect and deserve, (ii) encourage Resellers to invest in the promotion and service of the Products, (iii) promote inter-brand competition between the Products and third-party products and (iv) maintain the premium brand image of the Products and the goodwill of consumers.

### POLICY MODIFICATIONS

Valent BioSciences may amend or withdraw this Retailer Pricing Policy or designate promotional periods during which terms change or are inapplicable at its sole discretion. Resellers are responsible for remaining current with Valent BioSciences’ Policy, Price List, and Products.

### MONITORING & AUDITING

Valent BioSciences will implement this Retailer Pricing Policy and monitor for compliance using its own resources. As part of this policy, Valent BioSciences reserves the right to audit Reseller point-of-sale (POS) transaction records to ensure compliance.

### COMPLAINTS

No Reseller is required or encouraged to report any other Reseller’s noncompliance. If a Reseller chooses to report another dealer’s noncompliance, such report should be directed solely to Valent BioSciences via email at [compliance@valentbiosciences.com](mailto:compliance@valentbiosciences.com).

### POLICY

While each Reseller remains free to set its resale prices for Products independently and in its sole discretion, Valent BioSciences reserves the right to cease to supply Products to any Reseller who advertises, promotes, or sells Products to end-users at a price below the communicated Minimum Suggested Grower Price. Advertising, marketing, or promotion for purposes of this Retailer Pricing Policy, shall include any presentation, offer, bid response, or solicitation to sell Products by a Reseller. This shall include, but is not limited to, quotes, price lists, newspaper and magazine advertisements, electronic advertising, radio, television, facsimiles, internet marketing, emails, catalogs, flyers other direct mail, signs, billboards, or banners. The applicable price shall take into account all offered discounts and rebates. For example, an offer of “10% off all Valent BioSciences products” will not be compliant if the final price for any Product falls below the Minimum Suggested Grower Price.

### UNILATERAL ACTION

This Retailer Pricing Policy is unilateral and does not represent an agreement between Valent BioSciences and any Reseller, and Valent BioSciences does not and will not seek or accept agreement with respect to resale prices. As such, this Retailer Pricing Policy is non-negotiable and individual representatives are not authorized to alter, waive, modify, or negotiate this Retailer Pricing Policy. This Retailer Pricing Policy applies to all of Valent BioSciences’ Resellers. Resellers are free to advertise, promote, and sell any Product at a price of their own choosing, however, violations may result in loss of product supply.

### NONCOMPLIANCE

Each Reseller is solely responsible for deciding whether to comply with this Retailer Pricing Policy. Valent BioSciences is solely responsible for determining whether a Reseller has chosen not to comply with this Retailer Pricing Policy and for imposing consequences if a Reseller so chooses. Consequences include, but are not limited to: (1) suspending shipments of the product that is advertised, promoted, or sold in violation of this policy for a minimum of twelve months; (2) suspending shipment of a broader category of Products for a minimum of twelve months; (3) suspending shipment of all Products for a minimum of twelve months; and (4) terminating Valent BioSciences’ relationship with the Reseller for a period not less than three years. In the event of a violation and suspension or termination of shipments, Valent BioSciences has, at its sole discretion, the option to repurchase such inventory as the Reseller may possess (at the original purchase price). Noncompliance with this Retailer Pricing Policy will have the same effect whether it is deliberate or inadvertent. Consequently, Valent BioSciences will not accept any explanation or excuse from a Reseller who has failed to comply. Neither will Valent BioSciences accept any promise of future compliance.
